Struktura in finančna vrednost razpisa

Skupna vrednost razpisa za leto 2014 znaša 150,08 Mio.EUR, za leto 2015 157,82 Mio.EUR

- **Financiralo** se bo 100% upravičenih stroškov pri vseh tipih projektov (research and innovation action, CSA), razen pri specifičnih projektih namenjenih SME (70% upr. stroškov)

- Pozor pri projektih, ki vključujejo sodelovanje z regijami in tretjimi državami

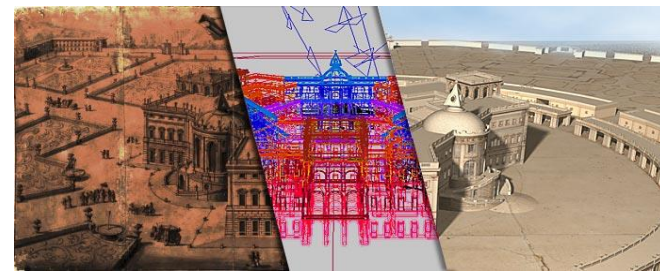

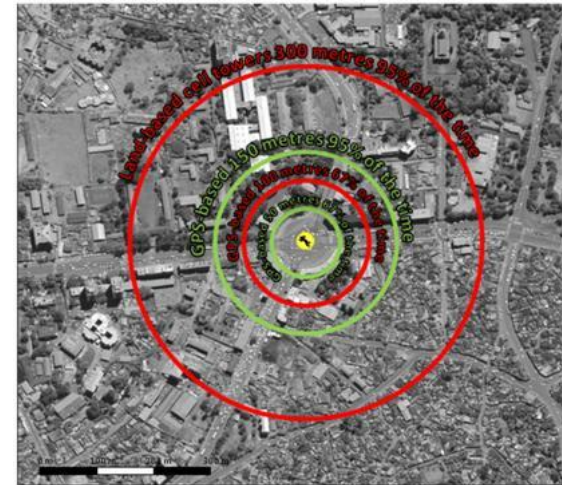

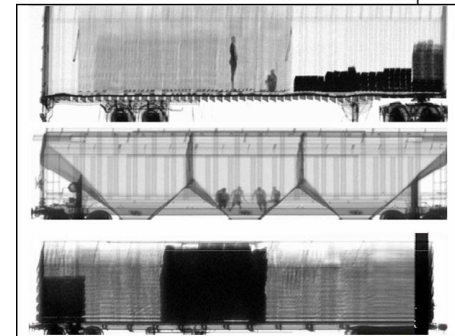
