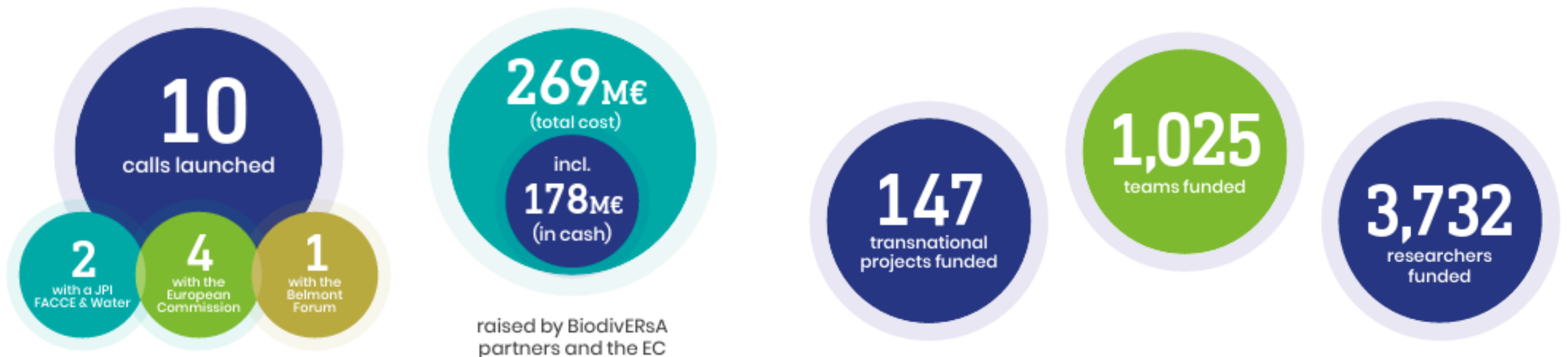

What is Biodiversa+?

- The **European biodiversity Partnership** co-funded by the European Commission under Horizon Europe
- **Supporting excellent research on biodiversity with an impact for policy and society**
- Officially launched on 1 October 2021 for a 7 years duration
- Jointly developed by BiodivERsA and the European Commission (DG Research & Innovation and DG Environment) – **building on the BiodivERsA experience (2008-2021)**

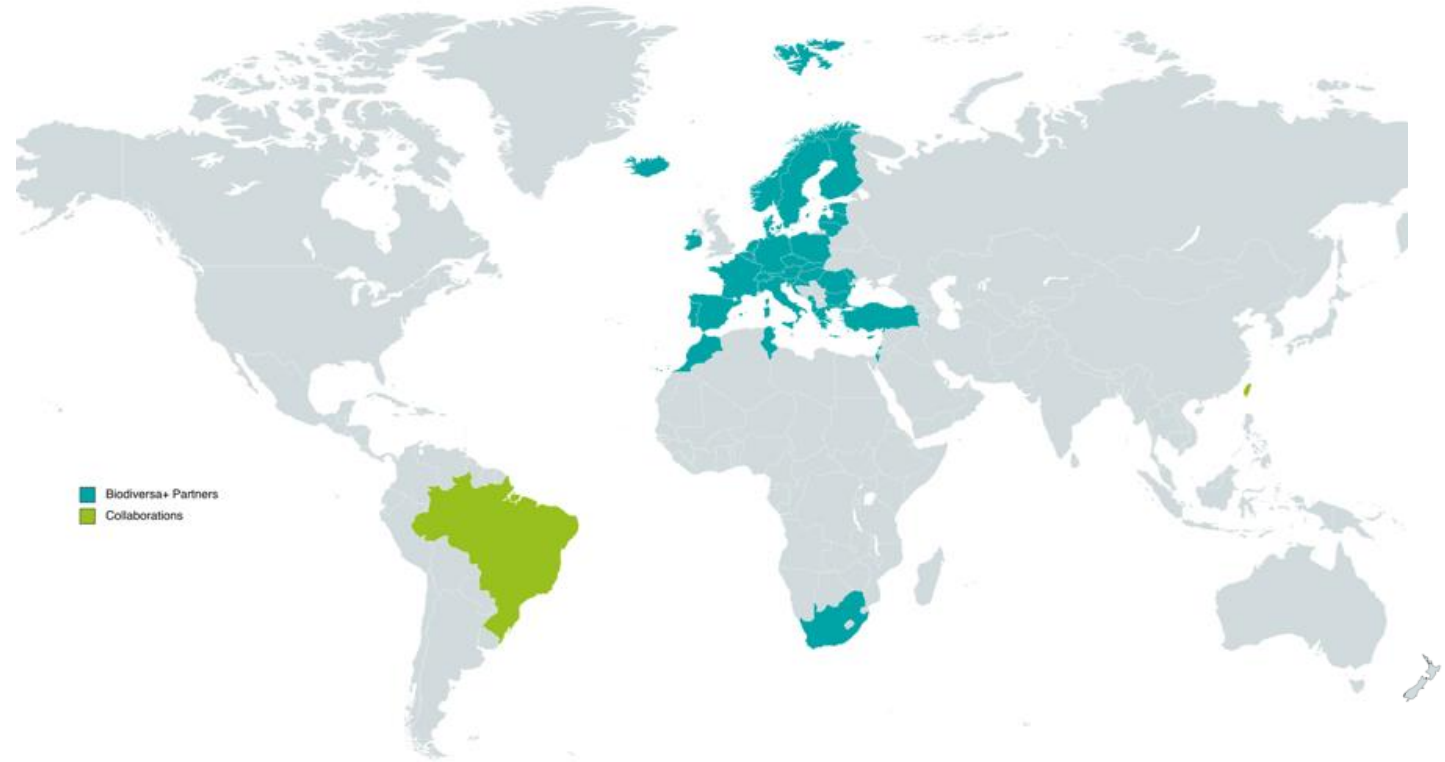

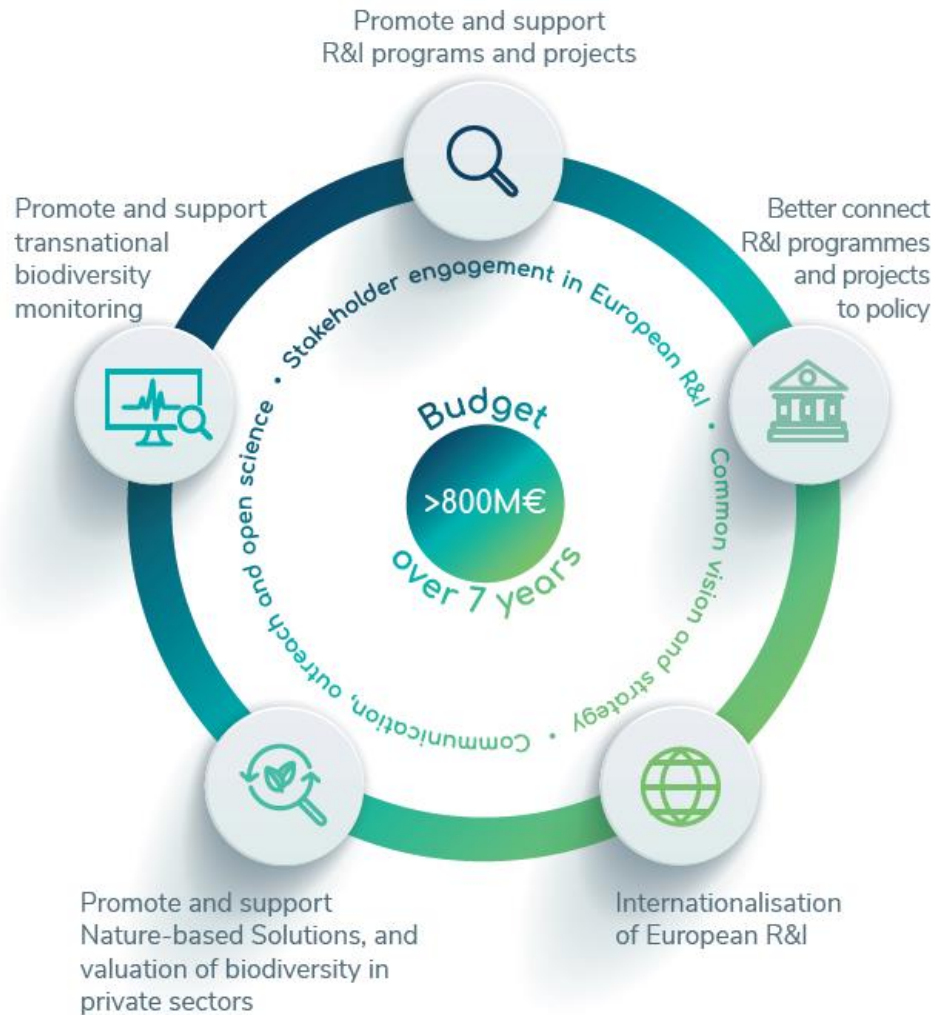

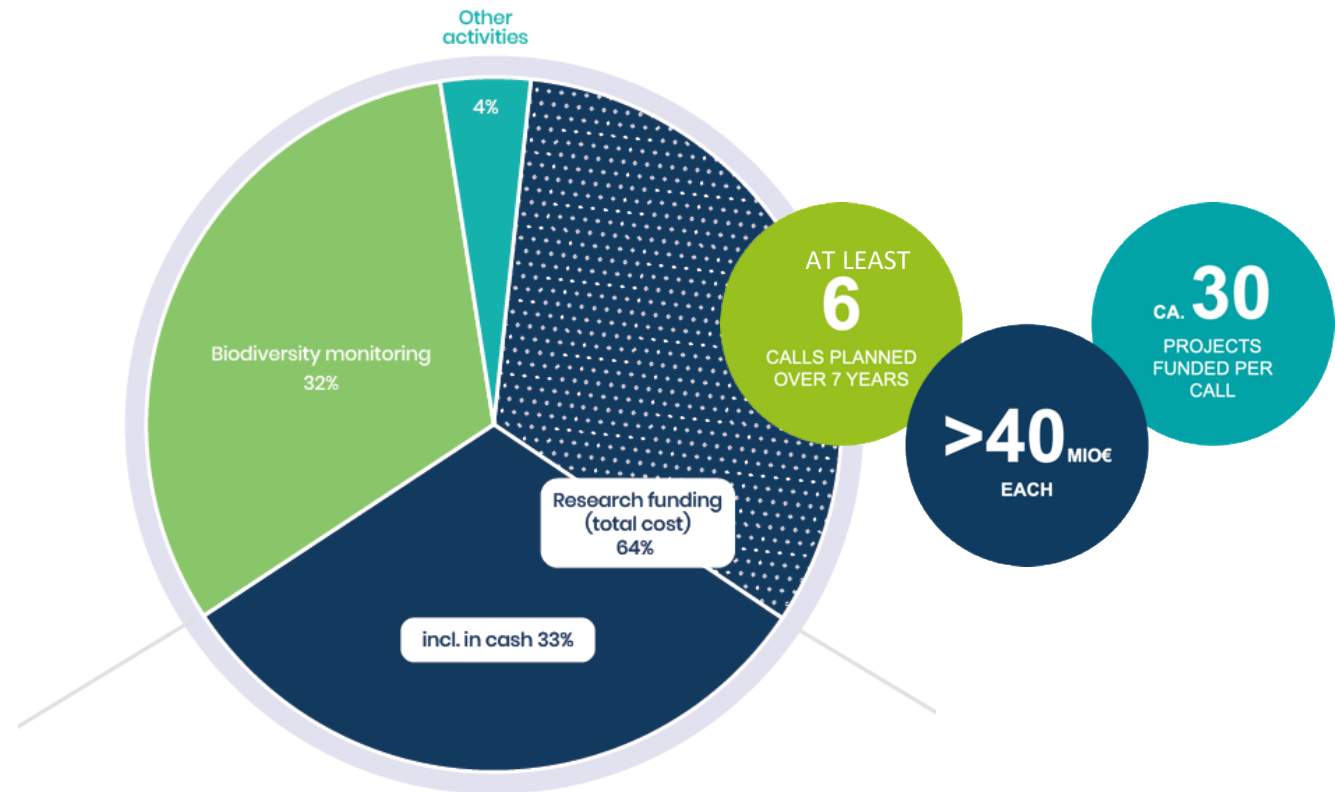

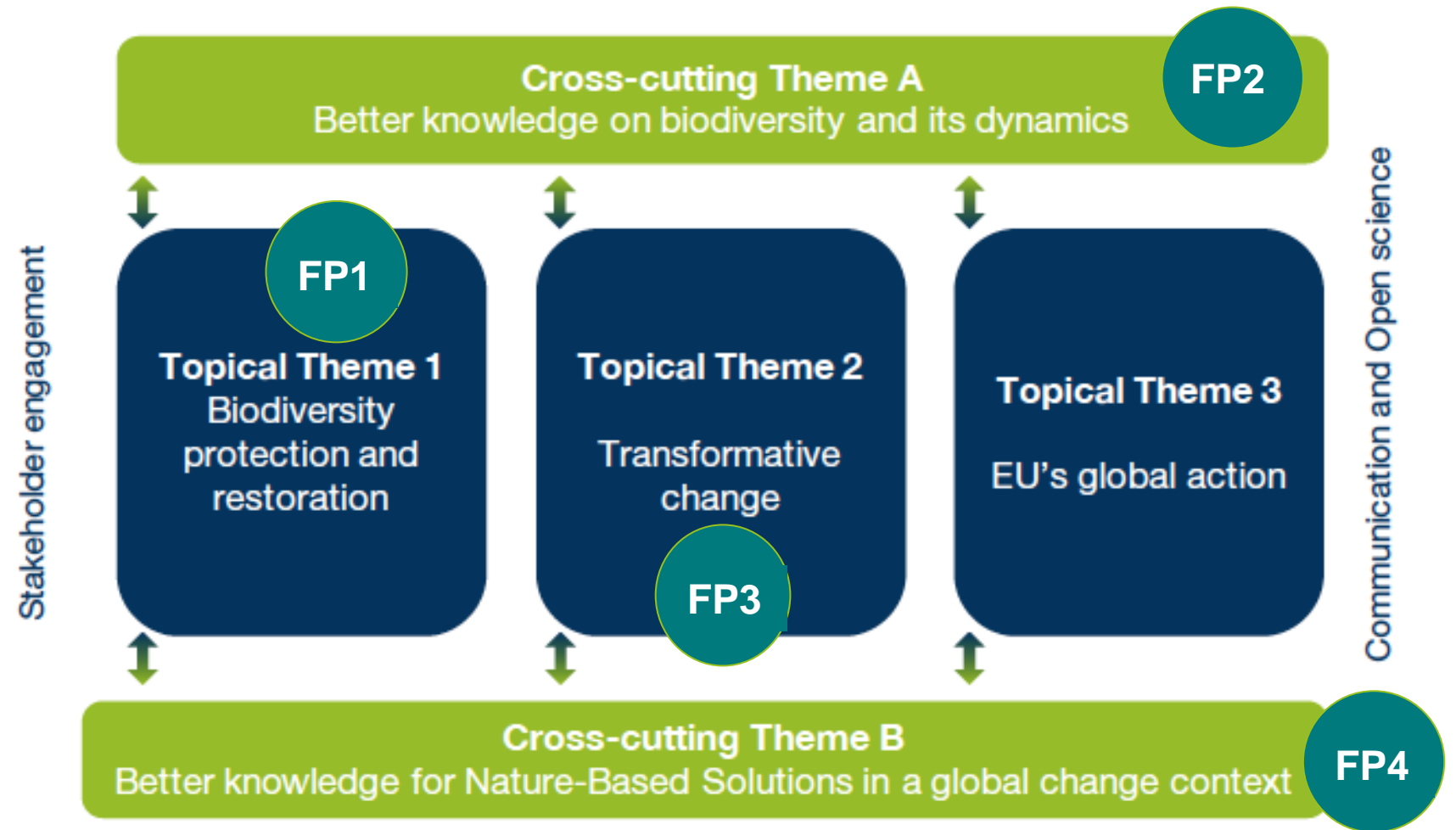
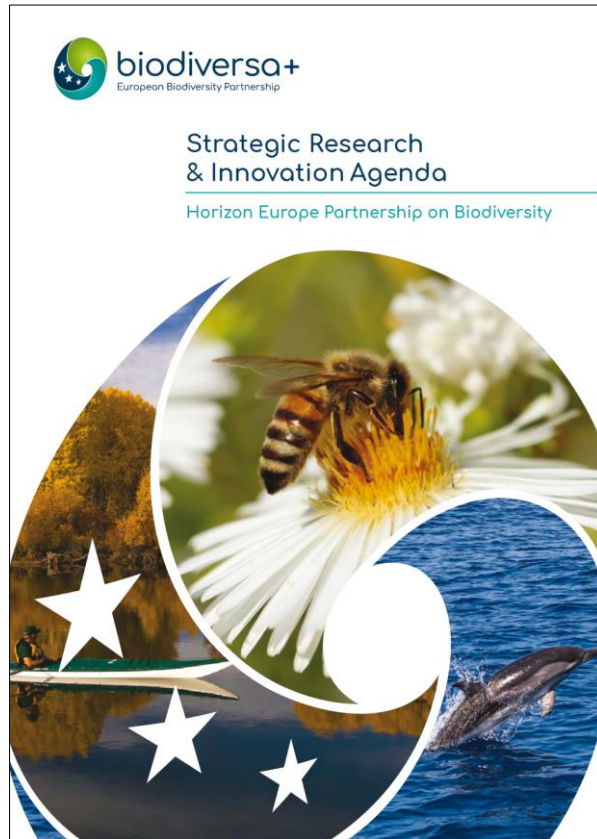
Portfolio of activities and budget amplitude

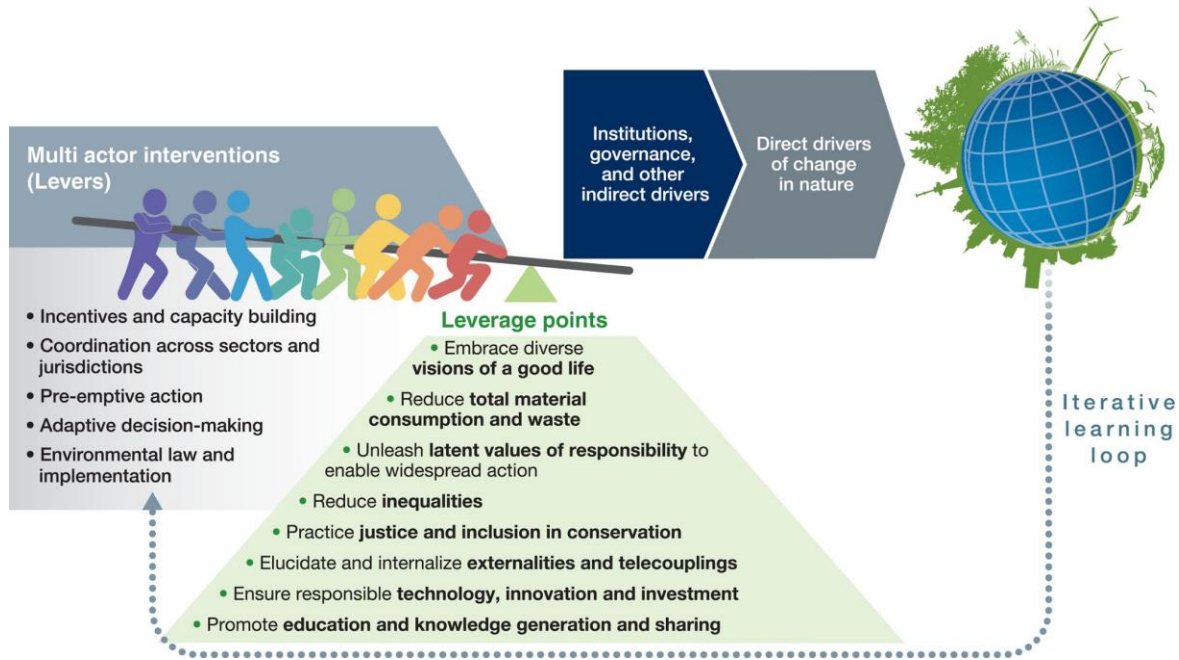

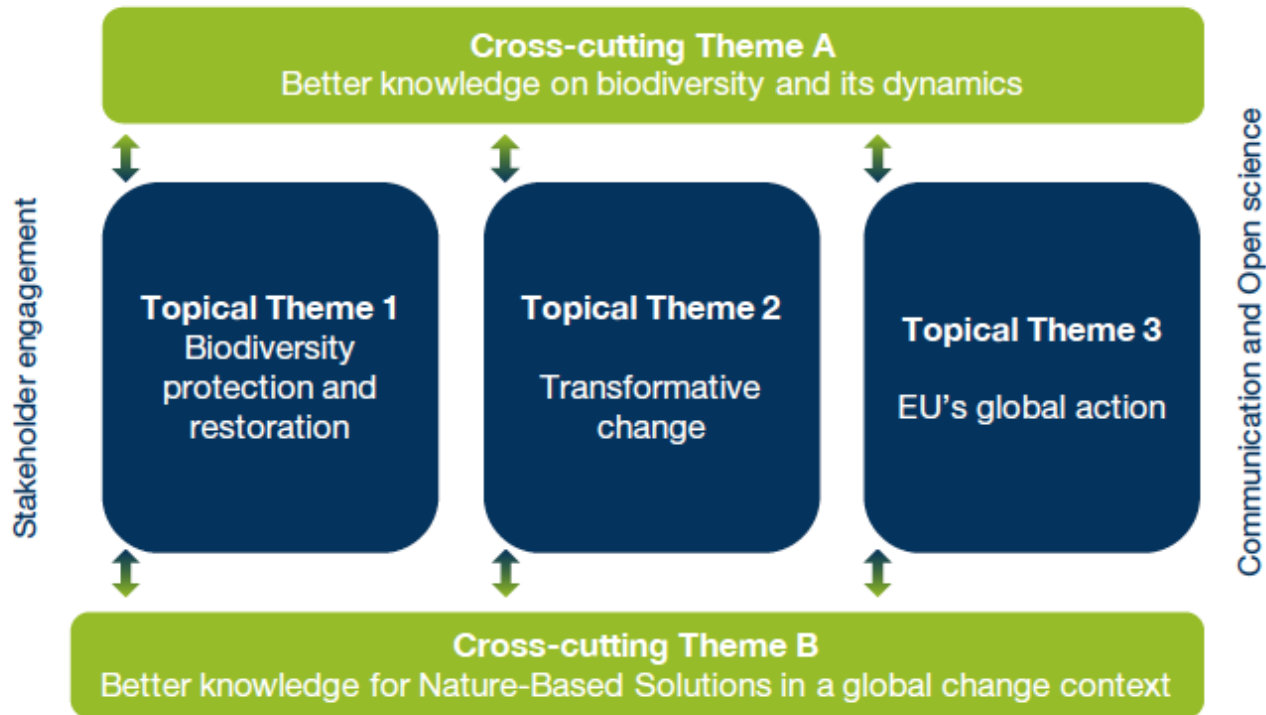

Circular Economy - Areas for collaboration



- How Circular Economy is understood/ understood
- Certain sectors (such as food and agriculture, forestry) hold significant potential to become circular (land-use)
=> role of NBS!
=> tackling consumption
- Valuation / natural capital accounting => sustainable finance
- Enhance policy coherence
- Global impact beyond EU borders
- Stronger embedding of natural & social sciences

2023 - 2024 joint call

The third Biodiversa+ annual joint call for research will be on the topic of **Nature-based Solutions**.

This call will be embedded in our **flagship program “Better knowledge to develop, deploy and assess nature-based solutions”** and will be co-funded by the European Commission.

Indicative timing

- ▶ **Spring / Summer 2023:** Official pre-announcement of the call, with further information on its topic and the themes that it will address
- ▶ **September 2023:** Launch of the **BiodivNBS** call
- ▶ **November 2023:** Deadline for the submission of pre-proposals

2024 - 2025 joint call

The fourth Biodiversa+ annual joint call for research will be on the topic of **Societal Transformation**.

This call will be embedded in our **flagship program “Supporting societal transformation for the sustainable use and management of biodiversity”** and will be co-funded by the European Commission.

Indicative timing

- ▶ **Spring / Summer 2024:** Official pre-announcement of the call, with further information on its topic and the themes that it will address
- ▶ **September 2024:** Launch of the **BiodivTransform** call
- ▶ **November 2024:** Deadline for the submission of pre-proposals

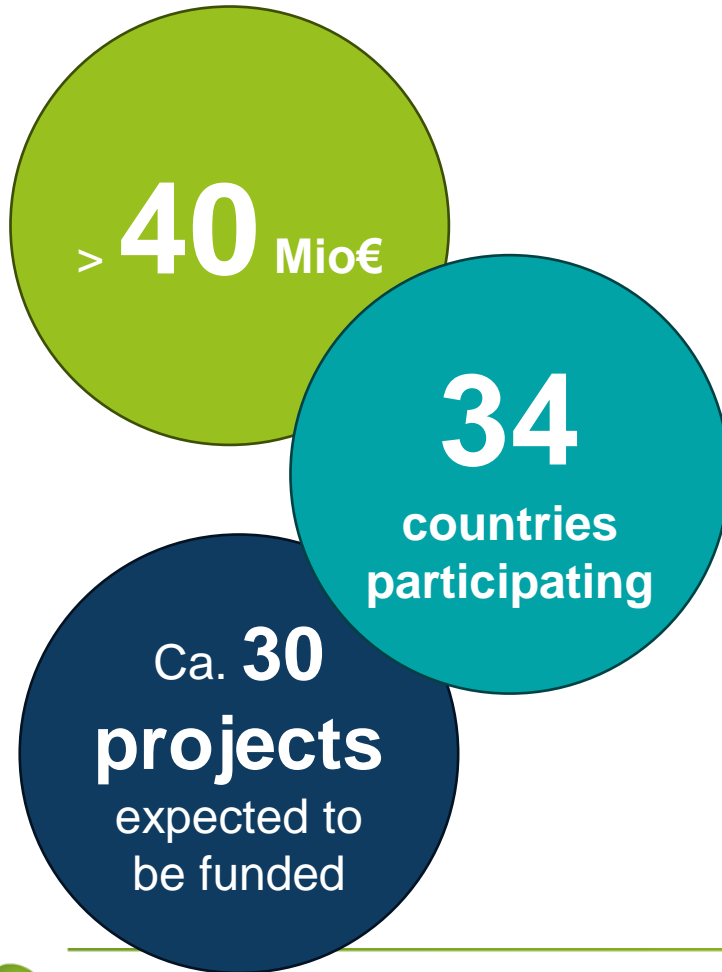
