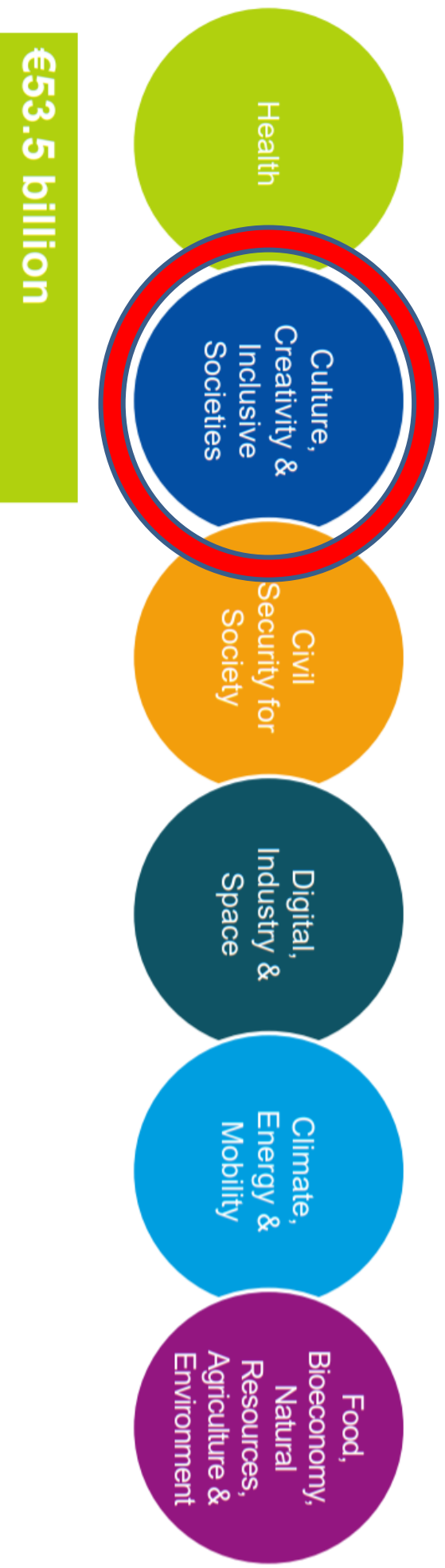

Cluster 2 foundations

- I. Meeting EU goals and priorities on:
 - a. Enhancing democratic governance and citizens participation
 - b. Safeguarding and promotion of cultural heritage
 - c. Responding to and shaping multifaceted social, economic, technological and cultural transformations
- II. Mobilise multidisciplinary expertise of European social sciences and humanities for understanding fundamental contemporary transformations of society, economy, politics and culture.
- III. Provide evidence-based policy options for a socially just and inclusive European green and digital transition and recovery.

Cluster 2 synergies (examples)

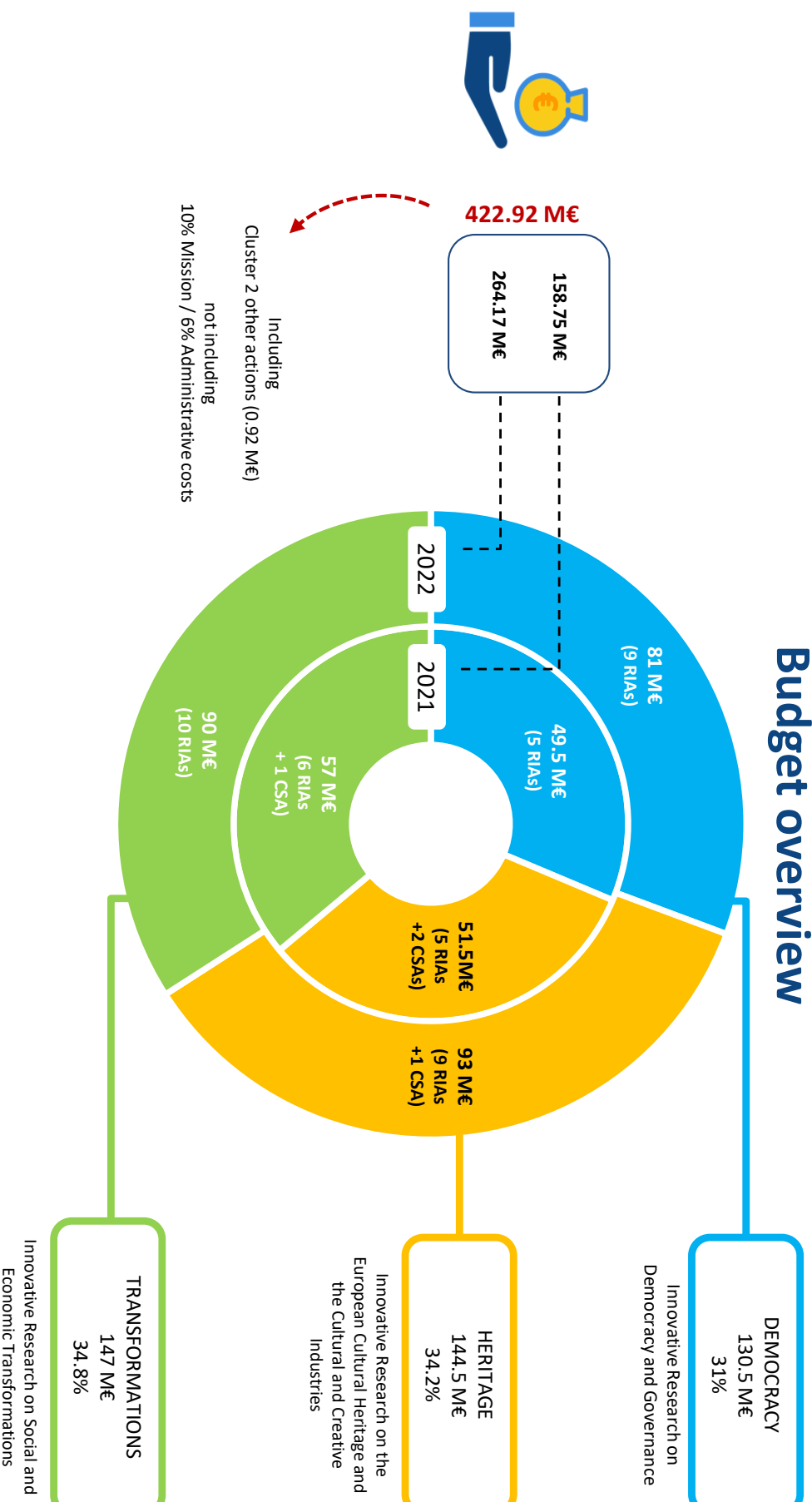
- Creative Europe: apply the latest technologies, stimulate new scientific approaches and boost innovation in Cultural heritage and CCI sectors
- Erasmust+: innovative practices for migrant integration in education, up-take of innovative methods for citizen engagement and education for fostering EU values and democracy stemming from Horizon Europe
- Neighbourhood, Development and International Cooperation Instrument: drawing on the findings in Horizon Europe projects regarding trust in governance, tackling disinformation and active citizenship
- Digital Europe Programme: wide uptake and deployment of innovative digital solutions, areas of public interest (including public administration, justice and education). Priorities include AI-based technologies in all EU languages and the EU digital platform for cultural heritage, Europeana, supporting digital transformation of cultural heritage institutions.

Cluster 2 synergies (examples)

- European Regional Development Fund: helping governments reap the benefits of digitisation and also encourage investments in social and cultural infrastructure, the development of cultural services and the conservation of cultural heritage.
- InvestEU Programme: funding the up-take of R&I results related to Cultural and Creative Industries (CCI) and cultural heritage
- Asylum and Migration Fund: Horizon Europe contribution by providing an evidence base for policies and projects, as regards asylum protection, legal and irregular migration management and migrant integration

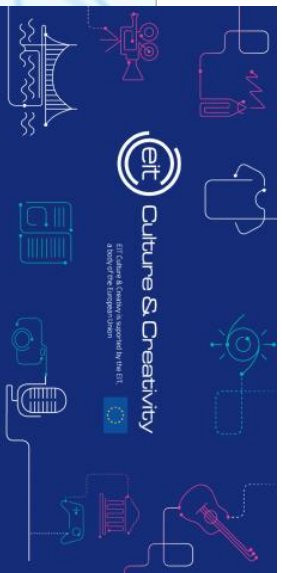

New European Bauhaus

The New European Bauhaus initiative connects the European Green Deal to our living spaces: „**to make the Green Deal a cultural, human centred and positive, “tangible” experience**”.

Bauhaus phases:

- *Co-design* (October 2020 to Summer 2021): gathering and connecting concrete contemporary examples that showcase principles of the New European Bauhaus. The outcome of the co-design phase will be a support framework based on EU programs, including a call for proposals for pilots in different EU Member States where the new Bauhaus concept will come to life.
- *Delivery* (September 2021): setup and implementation of New European Bauhaus pilots, supported by specific calls for proposals;
- *Dissemination* (January 2023): focus will be on **amplifying the ideas and actions that emerged** and reaching a broader audience in Europe and beyond. Networking and systematically sharing knowledge between participants and practitioners.
