- 2. The reason is the lack of a law that would enable commercial enterprises to engage in this activity.


HELICOPTER MEDICAL CAPABILITIES

Helicopter medical services offer rapid response and access to remote areas, enabling timely transportation of critically ill or injured patients.

The ability to land in confined spaces and navigate challenging terrain is crucial for swift medical intervention.

"THE REGULATION OF THE FIELD AROUND THE WORLD."

- In the United States of America, HEMS (Helicopter Emergency Medical Services) and HAA (Helicopter Air Ambulance) operate in both the public and private sectors. Operators must obtain certification from the Federal Aviation Administration (FAA) and adhere to strict regulations for flight safety and medical care.
- In Canada, HEMS and HAA operators are required to obtain permission from the Department of Transportation (Transport Canada) and comply with regulations for aviation services and safety.
- Germany has a structured operation of HEMS and HAA operators within emergency medical service organizations and hospitals, both in the public and private sectors. Oversight encompasses personnel training standards and operational procedures.
- In Australia, HEMS and HAA operators must acquire permission from the Civil Aviation Safety Authority (CASA) and adhere to regulations for safety and operations.
- In France, HEMS operators function under the supervision of the Civil Aviation Authority (DGAC) in close collaboration with health authorities, where operations are regulated by both aviation and health regulations.
- SLOVENIA, Military of Slovenia has right and authority.

-Luxembourg Air Rescue, performing helicopter medical transports in Luxembourg,

-Rega in Switzerland, specialized in emergency medical services and helicopter transports,

-Scandinavian MediCopter in Sweden, providing HEMS and HAA services.
